NEW PASSPORT

GUIDELINES FOR EXPEDITING YOUR NEW PASSPORT

- Proof of US citizenship
- Proof of Identification

CONSIDERED FIRST TIME

- It is the first time you are applying for a U.S. passport
- Your previous passport is expired and it was issued over 15 years ago
- Your passport was issued when you were a minor- under age of 16





CHILD PASSPORT

GUIDELINES FOR EXPEDITING YOUR CHILD'S PASSPORT

- This service is for Infants and children under 16 years of age

YOU QUALIFY FOR THIS SERVICE IF YOU ANSWER YES TO ONE OF THE FOLLOWING:

- I am a child applying for a US passport for the first time.
- I am a child whose previous US passport has expired or is about to expire.
- I am a child whose previous US passport has been lost or stolen.
- I am a child whose name has been changed through court order from the time my last US passport was issued.

GUIDELINES FOR EXPEDITING YOUR PASSPORT RENEWAL

- Proof of US citizenship
- Proof of Identification

CONSIDERED FOR PASSPORT RENEWAL (ALL CONDITIONS MUST BE MET):

- I have received my passport within the last 15 years or it expired less than five years ago
- I was over the age of 16 when my current passport was issued
- My passport is not damaged
- My name has not changed from the name in the passport (or I can legally document the name change by an original Marriage Certificate, Divorce Decree or Court Order)
